C. CONSIDERATION OF VETOED LEGISLATION - October 15th Council Meeting Agenda:

October 16, 2012

To: The City Council of East Point, GA

Re: Vetoes of Council Action of October 15, 2012

VETOES

This is formal notification that I am vetoing the actions taken by Council on October 15, 2012, concerning the following:

- 1) The motion to adopt Zoning Text Amendment: AN ORDINANCE TO AMEND PART 10, CHAPTER 2, ARTICLE B, SECTION 10-2044. D. I am vetoing this Ordinance because I do not believe that it is in the best interest of the City residents or visitors to allow a four inch space between an eight ft. security fence and a ten ft. electric fence. A youth or an adult could easily be shocked by the electric fence simply by sticking his/her hand through or over the four inch distance between the security fence and the electric fence. The alternative is to place the eight ft. security fence three ft. from the ten ft. electric fence and not to allow electric fences in the City's "BP" business park zoning district. Do we really want ten ft. electric fences with a security fence in front of it in our business park district? Therefore, I am requesting the Council not to override my veto.
- 2) The motion to **Approve Year 6 CIP Projects**. I am vetoing this motion because it includes the Pearl Street Stormwater Project. The remaining estimated CIP funds of \$5 million need to be used to take care of Water and Sewer Projects. One-third of the \$52 million allocated for construction and design has been spent on Stormwater projects. The Water and Sewer Utilities do not have reserves or capital outlay funds for any emergency or needed projects identified in the original list of water and sewer projects. The Water and Sewer Utilities will have to raise residential and commercial rates above the **\$64.80** rate that was voted in on June 20, 2011, and later reduced to **\$47.80** in February 2012. The General Fund is already having financial problems without incurring more stormwater debt. Therefore, I am requesting the Council not to override my veto.

3) The motion to enter into the U.S. ENVIRONMENTAL PROTECTION AGENCY AGREEMENT FOR THE Pearl Street Flooding Project. I am vetoing this motion because the City's match for this grant is \$1,098,200. The Council voted to use CIP funds for the match. I stated my intentions to veto this action with the full knowledge that my veto would kill the \$486,517 offered in the grant because of the October 19th deadline for submission. I requested that the Council reconsider and change the funding source to the Stormwater Utility. No one on the Council agreed to do so.

The Stormwater Utility is created to address projects like the flooding at Pearl Street and in the Sun Valley subdivision. Stormwater funds cannot be used to address any of the Water and Sewer Utilities projects such as building a water tower or dredging the Ben Hill Reservoir. Flooding projects along with other related stormwater run-off issues prompted the City to create a Stormwater Ordinance that is long overdue for passage. For these reasons, I am requesting the Council not to override my veto.
