- 2) **When did Mayor and Council vote to create a Wednesday Wind Down Enterprise with a Budget, Goals, under the Supervision of the City Manager for Implementation?**
- 3) **When did CM Sharon Shropshire become a Market/Booking Agent that would not conflict with her Elected Official status?**
- 4) **Why is Mayor and Council allowing this gross illegal activity to go on without any oversight and in violations of the City Charter, Operating Ordinances, Ethics Ordinance, and their Oath of Office?**
- 5) **Why shouldn't the Mayor and every Council Member be held personal libel for the misappropriations of funds used to pay the exorbitant expenses incurred by the Wednesday Wind Down Enterprises?**
